

## Pioneer moves ahead on consolidating and modernising its Embroidery Business

- Closing down labour-intensive Embroidery unit at Coimbatore
- Sale proceeds to be used in greenfield, state-of-the-art embroidery unit at Dhule

**Mumbai, July 29, 2022, Pioneer Embroideries Limited (PEL),** one of the key players in the Embroidery & Laces (EL) business in India and owner of brand "HAKOBA", is shutting down its labour-intensive embroidery manufacturing unit at Coimbatore. The factory land and building will be monetised, and the old, low-speed embroidery machines would also be disposed off, as these have already served their useful life. The Company shall shut down Coimbatore manufacturing unit, effective July 31, 2022.

PEL continues its strategic initiative of modernising and consolidating EL business. PEL had earlier announced that existing embroidery units will be sold over a period of time and it would consolidate its embroidery business at Shree Ganesh Textile Park, Degaon, Dhule, to benefit from enhanced efficiency and economies of scale

PEL enjoys good marketing reach and distribution network to cater to the domestic and overseas customers. In the near term, PEL will outsource embroidery manufacturing to serve its customers and retain overall current level of business. PEL shall also transfer Bobbin Lace machines to its existing factory at Sarigam, Gujarat, over the next two months, and does not expect any loss of business in the meantime.

PEL will use sale proceeds towards ongoing state of the art new embroidery project at Shree Ganesh Integrated Textile Park, Degaon, Dhule, Maharashtra.

Hence, Coimbatore closure will have insignificant impact on the overall sales and would prove EBIDTA accretive over medium-to-long term.

## **About Pioneer Embroideries Limited:**

Established in 1991 by Mr Raj Kumar Sekhani, Pioneer Embroideries Limited ("PEL") is one of India's notable manufacturers and exporter of value-added Specialized Polyester Filament Yarn and Embroidery & Laces. It has a state-of-the-art SPFY manufacturing facility at Himachal Pradesh and three Embroidery & Laces manufacturing facilities in Gujarat, Dadra & Nagar Haveli and Tamil Nadu.

Within a few years, PEL has carved a permanent niche for itself in the SPFY business worldwide, with best-in-class quality under the *SILKOLITE* brand. PEL has a yarn capacity of about 18,000 MT pa. The Company's products find application mainly in the non-apparel segment, used in carpets, bath mats, upholstery fabrics, and curtains. PEL became one of the first textile companies to create a brand in a highly commoditized yarn business.

PEL has a capacity of around 14 mm meters for laces and about 1,700 mn stitches of embroidery. PEL's products enjoy a premium in the marketplace because of better quality, design, and capacity. Owners of the heritage brand – *Hakoba* – PEL has over the years added strength to the brand by building upon an extensive library of embroidery designs, making Hakoba synonymous with high-quality embroidery across the world.

At present, the Company has two active embroidery and lace manufacturing facilities at – Naroli (UT DN&H) and Sarigam (Gujarat), along with a wide marketing presence at all the major markets.
